Nomination Rules

- Nominations are open to all Iowa-licensed nursing facilities, residential care facilities, and intermediate care facilities for persons with mental illness or intellectual disabilities.
- A resident or a family member of a resident may nominate a facility for the award. Facilities may not nominate themselves.
- All nominations will be evaluated by the Iowa Department of Inspections and Appeals (DIA) based upon the information provided, as well as the facility's history of regulatory compliance and other criteria.
- Representatives from DIA will visit the finalists to determine the winners.
- No more than two winning facilities may be selected from any one of the state's four congressional districts.
- Nomination forms may be downloaded from the department's website at dia.iowa.gov.
- Nominations must be postmarked **no later than March 1, 2021**. Nominations received for facilities in 2020 will be considered for 2021.
